Program items:

The individual descriptions to the chosen program items can be found on the website. The organizers may choose to change certain program items if circumstances demand. Should a program item have to be cancelled, the participation fee for this item will be refunded. Further claims towards the organizers do not arise.

Program schedule / Follow-up bookings:

All participants have to ensure that their registration is complete. All chosen program items are listed in the confirmation e-mail, which each participant will receive directly after completion of their registration within four business days.

Program reduction / Cancellation:

Each program reduction or cancellation has to be made in written form via e-mail to the following e-mail address: eba2016hungary@gmail.com. The e-mail date determines the cancellation fee. The registration team will reply within four business days confirming receipt of the cancellation. The cancellation is valid only after the participant has received the cancellation confirmation. The participant is obliged to ensure that he/she has received the cancellation confirmation and is responsible for ensuring that the cancellation was accepted by the organizers.

Last termin for registration: 15th of April, 2016.

Resignation: By any resignation submitted before 15th of April, the fee will be transferred back. In case the resignation is submitted before 30th of April, 60% of the fee will be transferred back. After this no refund is possible.

Hotel Booking

The hotel booking has to be done individually by each participant.
